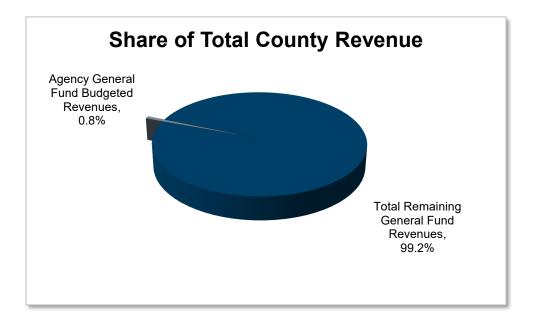
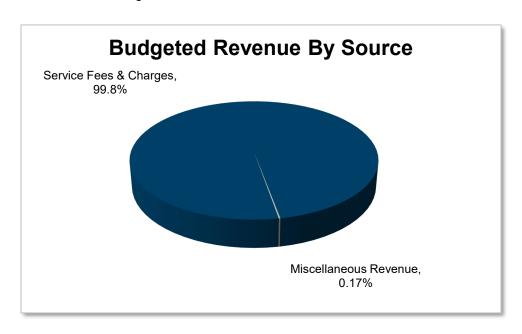


#### General Fund - Revenue Analysis

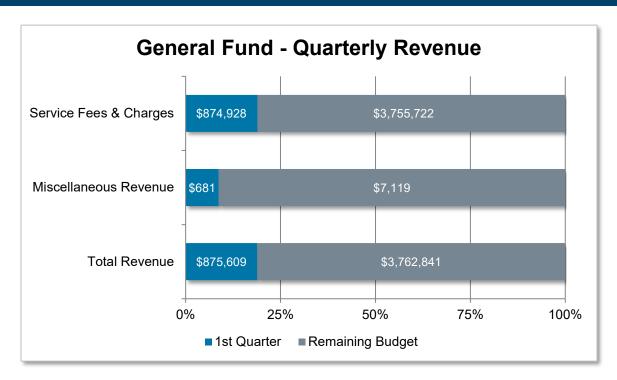


• The General Fund revenue for the Recorder's Office is estimated to be **\$4,638,450** for 2023, which is **0.8%** of the total budgeted revenue for the General Fund.



• The main sources of General Fund revenue for the Recorder's Office are fees based on the filings of mortgages and deeds.



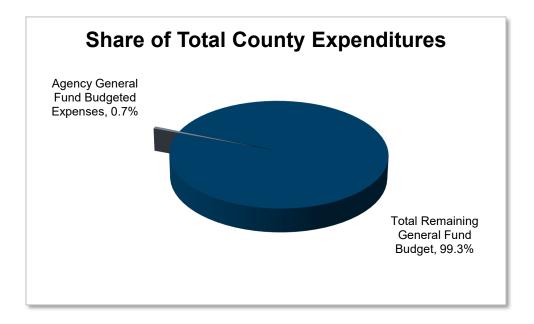

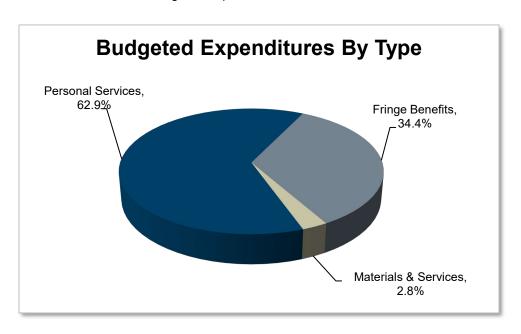
- First quarter revenue of \$875,609 represents 18.9% of the budgeted amount for the year.
- General Fees collected during the 1<sup>st</sup> quarter were \$862,959, which is 18.9% of the amount budgeted for the year. This amount represents a decrease of \$647,078 or 42.9% below the amount that was collected in the 1<sup>st</sup> quarter of 2022 due to a decrease in the filings of refinanced mortgages associated with the increase in interest rates.
- Housing trust administration fees collected during the 1<sup>st</sup> quarter were \$10,982, which is 18.5% of the amount budgeted for the year. This amount represents a decrease of \$8,697 or 44.2% below the amount that was collected in the 1<sup>st</sup> quarter of 2022.



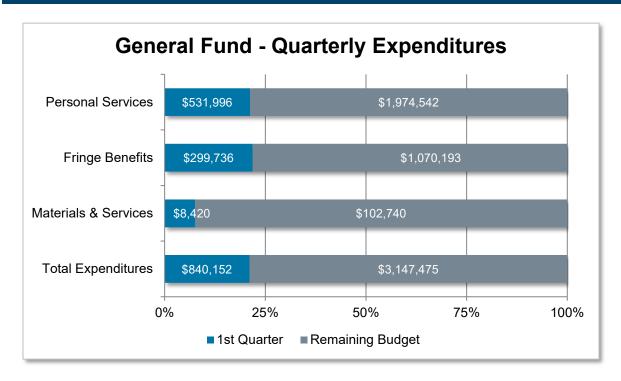
#### General Fund – Expenditure Analysis



• The General Fund expenditures for the Recorder's Office are estimated to be **\$3,987,627** for 2023, which is **0.7%** of the total budgeted expenditures for the General Fund.

- First quarter expenditures of \$840,152 represent 21.1% of the budgeted amount for the year.
- Personal Services expenditures during the 1<sup>st</sup> quarter were \$531,996 or 21.2% of the budgeted amount for the year.
- Fringe Benefit expenditures during the 1<sup>st</sup> quarter were \$299,736 or 21.9% of the budgeted amount for the year.
- Materials & Services expenditures during the 1<sup>st</sup> quarter were \$8,420 or 7.6% of the budgeted amount for the year. Material & Services expenditures were below the 25% threshold primarily due to the timing of professional services, training, and the purchase of office supplies.

• There were six pay periods through the end of the 1<sup>st</sup> quarter, which would equate to 23.1% of the budgeted amount. The variance is due to higher than anticipated vacancies.

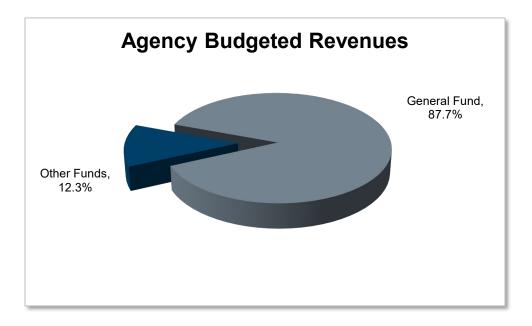

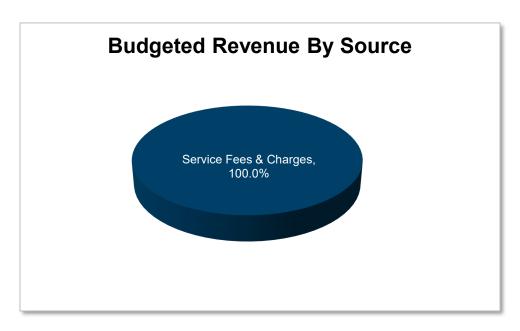

#### Non-General Fund – Revenue Analysis

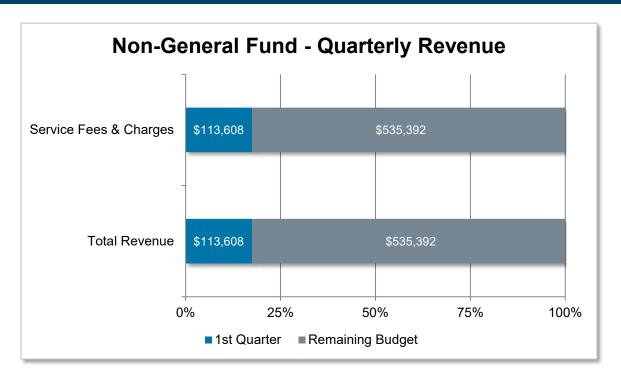


• The non-general fund revenue for the Recorder's Office is estimated to be **\$649,000** for 2023, which is **12.3%** of the total budgeted revenue for the Recorder's Office.



• The main source of non-general fund revenue for the Recorder's Office is a \$4.00 fee that is collected for every document filed and deposited into the Recorder's Technology Fund.



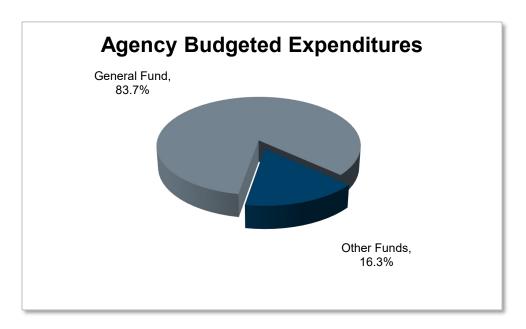

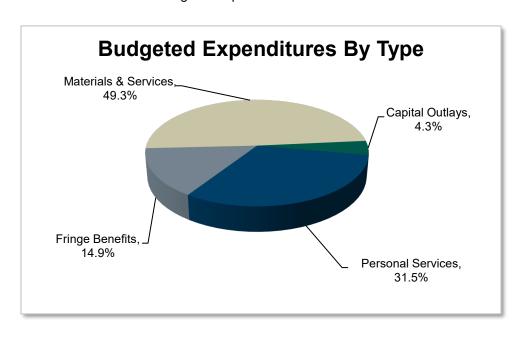
- First quarter revenue of \$113,608 represents 17.5% of the budgeted amount for the year.
- General Fees collected during the 1<sup>st</sup> quarter were \$113,608, which is 17.5% of the amount budgeted for the year. This amount represents a decrease of \$81,896 or 41.9% below the amount that was collected in the 1<sup>st</sup> quarter of 2022. due to a decrease in the filings of refinanced mortgages associated with the increase in interest rates.



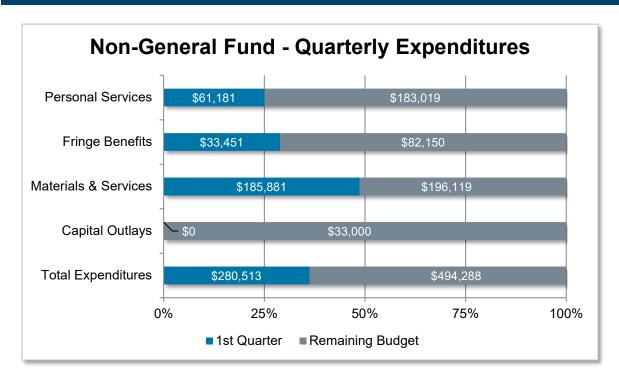
#### Non-General Fund – Expenditure Analysis



• The non-general fund expenditures for the Recorder's Office are estimated to be **\$774,801** for 2023, which is **16.3%** of the total budgeted expenditures for the Recorder's Office.

- First quarter expenditures of \$280,513 represent 36.2% of the budgeted amount for the year.
- Personal Services expenditures during the 1<sup>st</sup> quarter were \$61,181 or 25.1% of the budgeted amount for the year.
- Fringe Benefits expenditures during the 1<sup>st</sup> quarter were \$33,451 or 28.9% of the budgeted amount for the year.
- Materials & Services expenditures during the 1<sup>st</sup> quarter were \$185,881 or 48.7% of the budget amount for the year. The expenditures in the 1<sup>st</sup> quarter included the annual software maintenance payment for the Recorder's Document Management System, the annual payment for Microsoft licenses, and the purchase photographic materials and supplies.
- There were no expenditures within Capital Outlays during the 1<sup>st</sup> quarter. The budget is associated with any unforeseen capital needs in 2023.
