



# General Fund - Revenue Analysis




• The General Fund revenue for the Court of Appeals is estimated to be **\$191,420** for 2023, which is **0.03**% of the total budgeted revenue for the General Fund.



 The main sources of General Fund revenue for the Court of Appeals are reimbursements from the State Public Defender's Office for appointed counsel legal fees associated with indigent defense services.






- Second quarter revenue of \$85,634 represents 44.7% of the budgeted amount for the year. YTD revenue of \$108,053 represents 56.5% of the budgeted amount for the year.
- Revenue collected through the end of the 2<sup>nd</sup> quarter represents an increase of \$36,955 or 52.0% compared to the same timeframe in 2022 due to caseload fluctuations and the timing of reimbursements from the State Public Defender's Office.




# General Fund – Expenditure Analysis



• The General Fund expenditures for the Court of Appeals are estimated to be **\$398,068** for 2023, which is **0.1%** of the total budgeted expenditures for the General Fund.

- Second quarter expenditures of \$59,754 represent 15.0% of the budgeted amount for the year. YTD expenditures of \$170,702 represent 42.9% of the budgeted amount for the year.
- Total expenditures through the end of the 2<sup>nd</sup> quarter are comparable to same timeframe in 2022.

# General Fund - Personal Services Analysis

• There are no Personal Services expenditures for the Court of Appeals since those are paid by the State of Ohio.

#### General Fund - Budget Corrective Items - Approved

• There have been no approved budget adjustments to date.

#### General Fund - Budget Corrective Items - Pending

• There are no requests currently pending that may impact the budget.

#### Additional Budget Analysis

• The State Public Defender's Office notified counties that the approved version of the state biennial budget for fiscal years 2024-2025 (House Bill 33) included increased funding for county indigent defense which the State Public Defender's Office has set the initial reimbursement rate for the biennium at 85% based on the spending levels from the past four fiscal years, with particular attention to fiscal year 2023. Based on historical fluctuations, the County is anticipating a reimbursement rate of 80% for 2024.
