#### **COMMISSIONERS SUPPORT AMERICAN JOBS ACT**

Affirming their commitment to the core principles of job creation, strategic economic development and fiscal security for Franklin County families and businesses, Tuesday morning Franklin County Commissioners unanimously adopted a resolution in support of the passage of the American Jobs Act as proposed by President Obama and included as part of the President's long-term deficit reduction plan.

The Act will be funded through the Federal Administrations recommendations to the Joint Committee charged with deficit reduction, and focuses on creating jobs through infrastructure investment and business tax credits; preserving important public sector jobs like police, fire and teachers; and, providing relief to working Americans struggling by providing more opportunities to refinance their mortgages and cutting their payroll tax in half next year.

"Nearly 50,000 Franklin County residents were looking for work last month," said Commissioner Marilyn Brown. "Franklin County families and job seekers need employment opportunities like never before. The American Jobs Act not only puts people to work, it puts more money in the pockets of working families. In fact, if passed, the average working families will receive a \$1,500 tax cut next year. "

"The American Jobs Act will cut taxes, bolster small business and protect the public's safety," said Commissioner Paula Brooks. "Additionally it provides a new way of financing public infrastructure like roads and bridges that are sorely needed here. Congress should pass it now."

"The American Jobs Act is a budget neutral measure which creates real employment opportunities for American workers," said Commissioner John O'Grady. "Construction workers, teachers, young people and those who have been unemployed for an extended period of time will have access to more jobs without increasing the federal deficit. I encourage Congress to support this Act, as proposed by the President, and reduce the burden felt by families, veterans, businesses and the middle class in the Heartland and across the Nation."

## Resolution Supporting Passage of the American Jobs Act

### (COMMISSIONERS)

**WHEREAS**, the Franklin County Board of Commissioners identifies as one of its core principles the promotion of job creation, strategic economic development, & fiscal security in Franklin County; and

**WHEREAS**, the Franklin County Board of Commissioners supports federal policies that are consistent with this core principle; and

**WHEREAS**, the national economy continues to grow at a slow rate, with second quarter Gross Domestic Product (GDP) estimates being revised down to 1% and first-half growth rates for 2011 of only 0.7% - the weakest growth rate during an expansion since 1979; and

**WHEREAS**, employment growth continues to lag, as the national unemployment rate remains at 9.1%, the state unemployment has increased the last three months to 9.1% and Franklin County's unemployment rate is 7.9%; and

**WHEREAS**, President Barack Obama has introduced the American Jobs Act to Congress in an effort to stimulate the economy and create jobs; and

**WHEREAS**, the American Jobs Act contains measures to boost growth and increase employment immediately, including:

- Cutting payroll taxes for 98% of America's small businesses;
- Providing \$175 billion in tax relief to American workers;
- Providing grant allocations to states to prevent the layoffs of up to 280,000 teachers and the modernization of up to 35,000 schools;
- Providing for the creation of a National Infrastructure Bank and \$50 billion in immediate investments for highway, highway safety, transit passenger rail and aviation activities;
- Revising the unemployment insurance program to provide greater pathways back to work for Americans looking for jobs by providing \$5 billion for subsidized employment opportunities, summer & youth employment and work-based training for unemployed, low-income adults; and
- Allowing more Americans to refinance their mortgages at today's low interest rates; and

**WHEREAS**, the American Jobs Act as proposed by President Obama is included as part of the President's long-term deficit reduction plan; and

### **Resolution Supporting Passage of the American Jobs Act**

**WHEREAS**, the American Jobs Act is estimated to create 1.9 million jobs next year and reduce the unemployment rate by a full percentage point, according to the chief economist at Moody's Analytics, and boost U.S. GDP by 1.5% in 2012, according to Goldman Sachs; and

**WHEREAS**, passage of the American Jobs Act will assist in creating jobs in Franklin County by supporting job creation through infrastructure investment, mitigating teacher layoffs, providing more disposable income in citizen's paychecks and mitigating Franklin County foreclosures; now therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY OHIO:

- 1. That the United States Congress be urged to immediately pass the American Jobs Act as proposed to provide for the creation of 1.9 million new jobs;
- 2. That a copy of this resolution be respectfully submitted to the Ohio delegation members of the United States Congress urging their action in accordance thereto.
