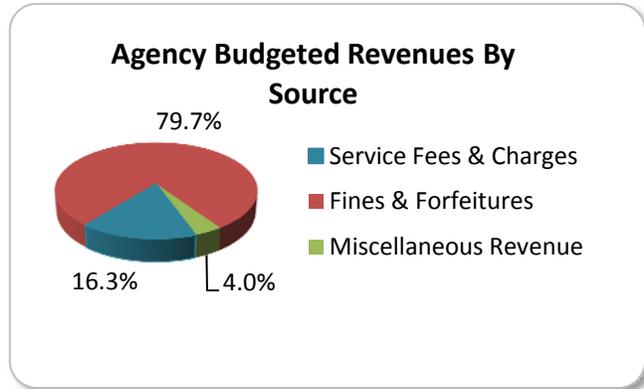
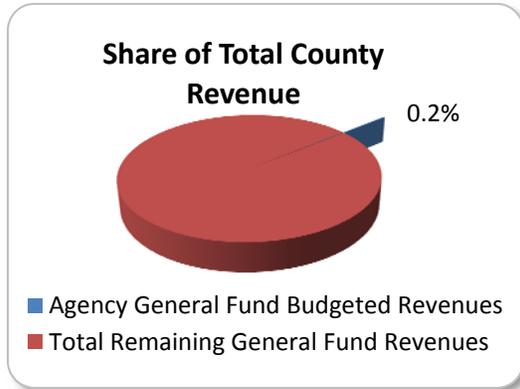
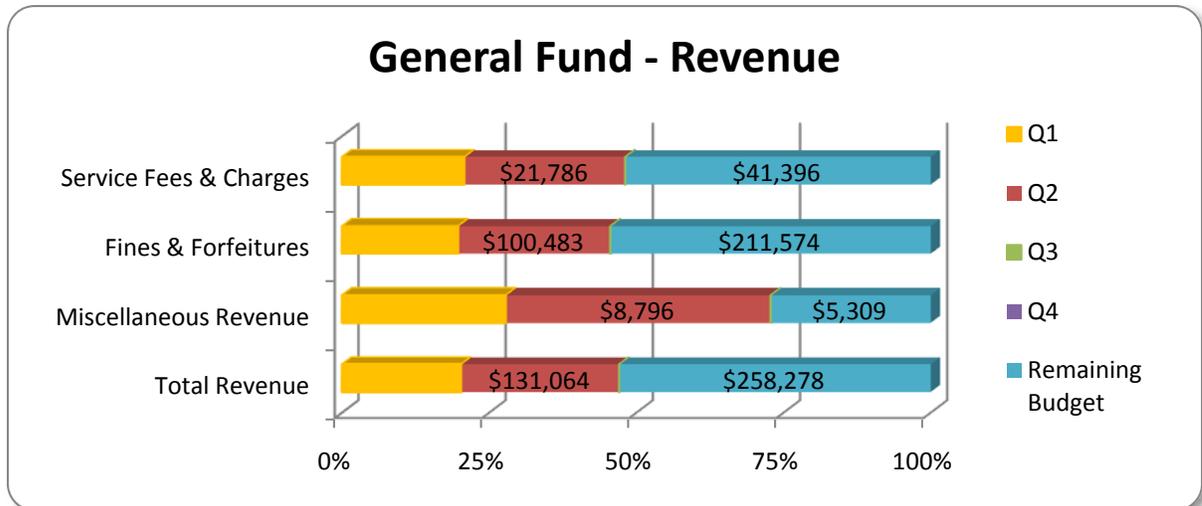


General Fund Analysis



- The General Fund revenue for the Municipal Court Clerk is estimated to be \$488,189 for 2010, which is 0.2% of the total budgeted revenue for the General Fund.
- The main sources of General Fund revenue for the Municipal Court Clerk are Municipal Court fines and forfeitures, which include 10% of Ohio Highway Patrol fines and liquor law violations; service fees and charges include application fees, per ORC 120.36, for indigent defense; juror fee reimbursements for offenses written under State code; and witness fee reimbursements for offenses written under State code.

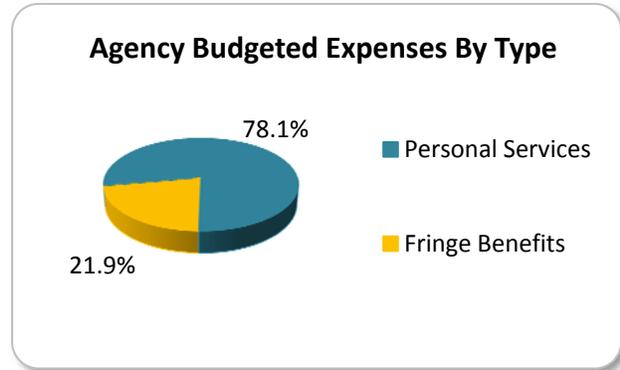
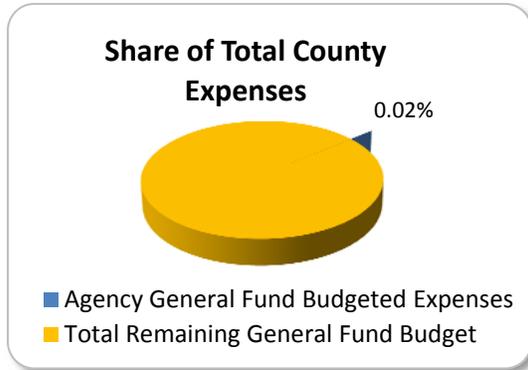

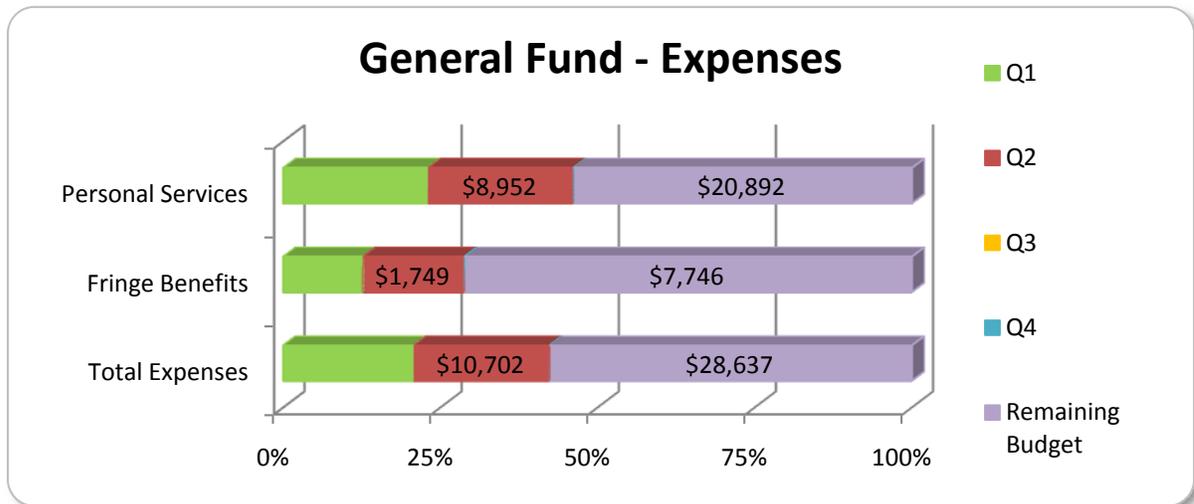

- Second quarter revenue of \$131,064 represents 26.9% of the budgeted amount for the year. YTD revenue of \$229,911 represents 47.1% of the budgeted amount for the year.
- There are no significant one-time revenues in the current quarter or YTD.

- The General Fund expenditures for the Municipal Court Clerk are estimated to be \$49,674 for 2010, which is 0.0% of the total budgeted expenditures for the General Fund.

- Second quarter expenditures of \$10,702 represent 21.5% of the budgeted amount for the year. YTD expenditures of \$21,037 represent 42.4% of the budgeted amount for the year.
- Expenditures for Personal Services in the 2nd quarter were \$8,952, 23.08% of the amount budgeted for the year. Within Fringe Benefits, the Clerk's healthcare is typically paid in January for the year. As of 2nd quarter, the invoice from the City for \$4,795.97 has not been submitted. Payment is anticipated to occur during 3rd quarter.
- There are no Materials and Services expenses in the Municipal Court Clerk's budget.
- There are no significant one-time expenses in the current quarter or YTD.
