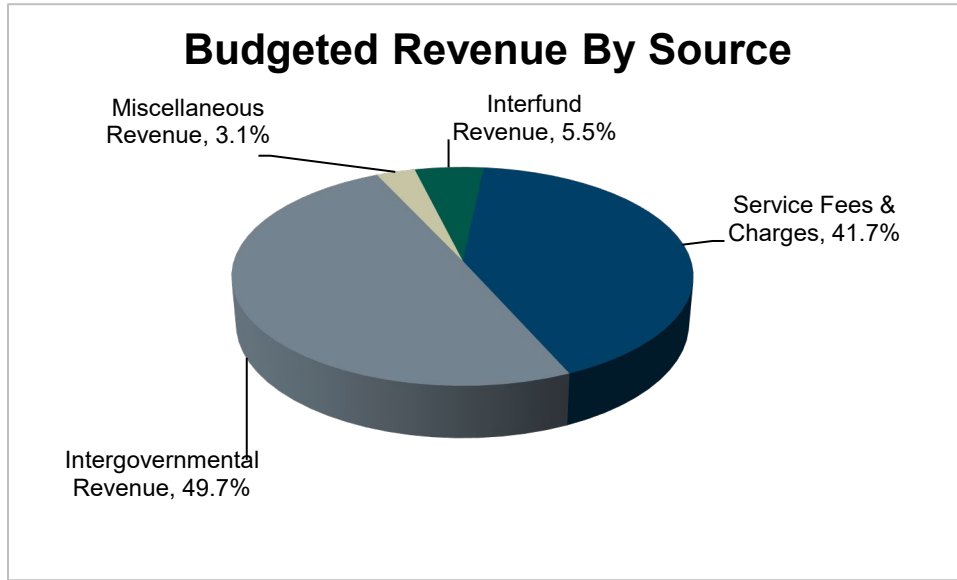
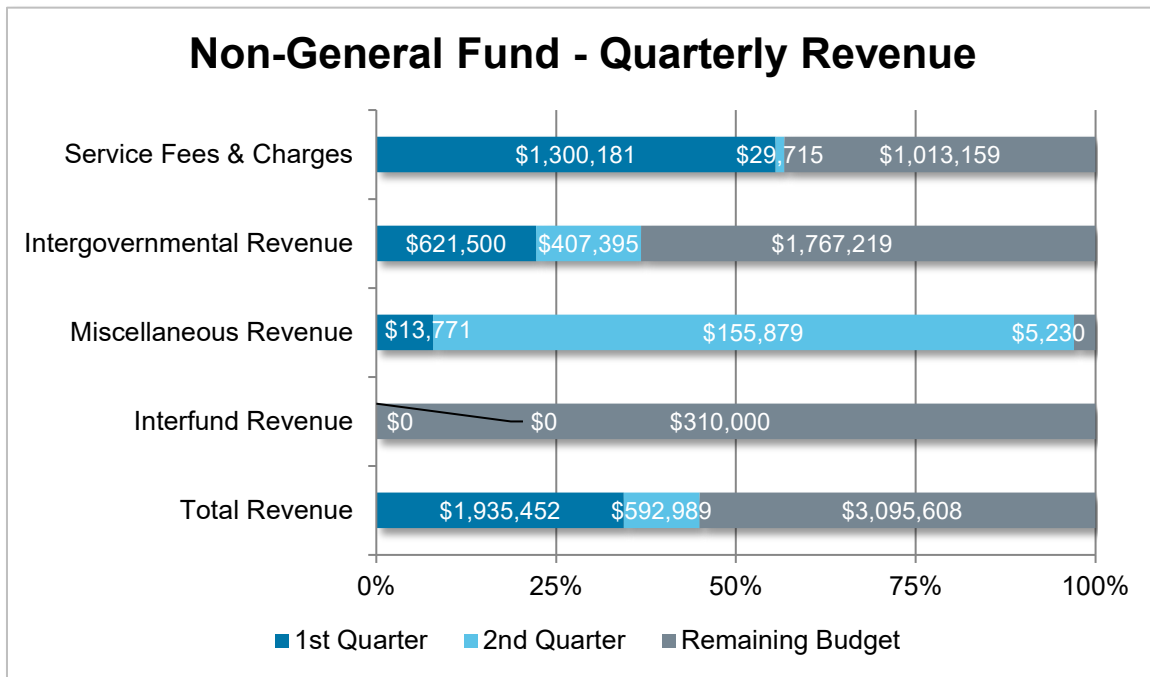


Non-General Fund – Revenue Analysis



- The non-general fund revenue for Emergency Management and Homeland Security is estimated to be **\$5,624,049** for 2022.
- The main sources of non-general fund revenue for Emergency Management and Homeland Security are proportionate share amounts received from participating entities, grants for local emergency management efforts, the Emergency Management Preparedness Grant (EMPG), financial support from the Chemical Emergency Preparedness Advisory Council (CEPAC), fees and reimbursements from the purchase of warning sirens, radio billing fees collected from County and other local government entities, and grants awarded from the Law Enforcement State Homeland Security Program.

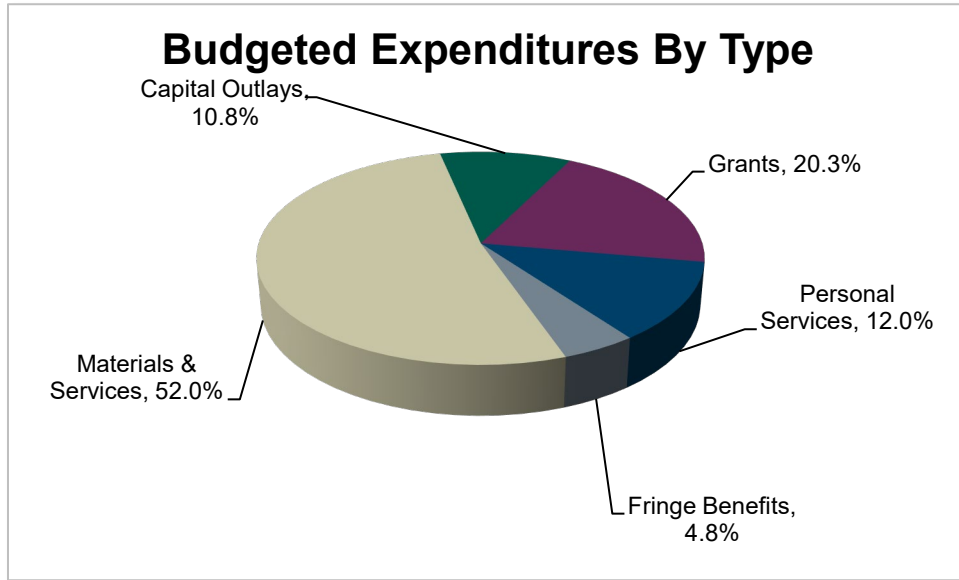

- Second quarter revenue of **\$592,989** represents **10.5%** of the budgeted amount for the year. YTD revenue of **\$2,528,441** represents **45.0%** of the budgeted amount for the year.
- The increase in revenue during the first half of the year is primarily due to the timing of federal grant reimbursements.
- Year-to-date Intergovernmental Revenue of \$1,028,895 represents 36.8% of the budgeted amount for the year. The remaining revenue is primarily derived from federal grants which are generally received in the 3<sup>rd</sup> and 4<sup>th</sup> quarters.
- Miscellaneous Revenue is primarily associated with the reimbursement from municipalities for the purchase of warning sirens. The revenue and associated expenditures are pass through and driven by the demand for repairs, replacements, and purchases of new sirens by municipalities.
- Interfund Revenue is related to the operating subsidy that is provided to the Homeland Security & Regional Communications Fund from the General Fund. Due to the carryover cash balance, the operating subsidy won't be required until later in the year.

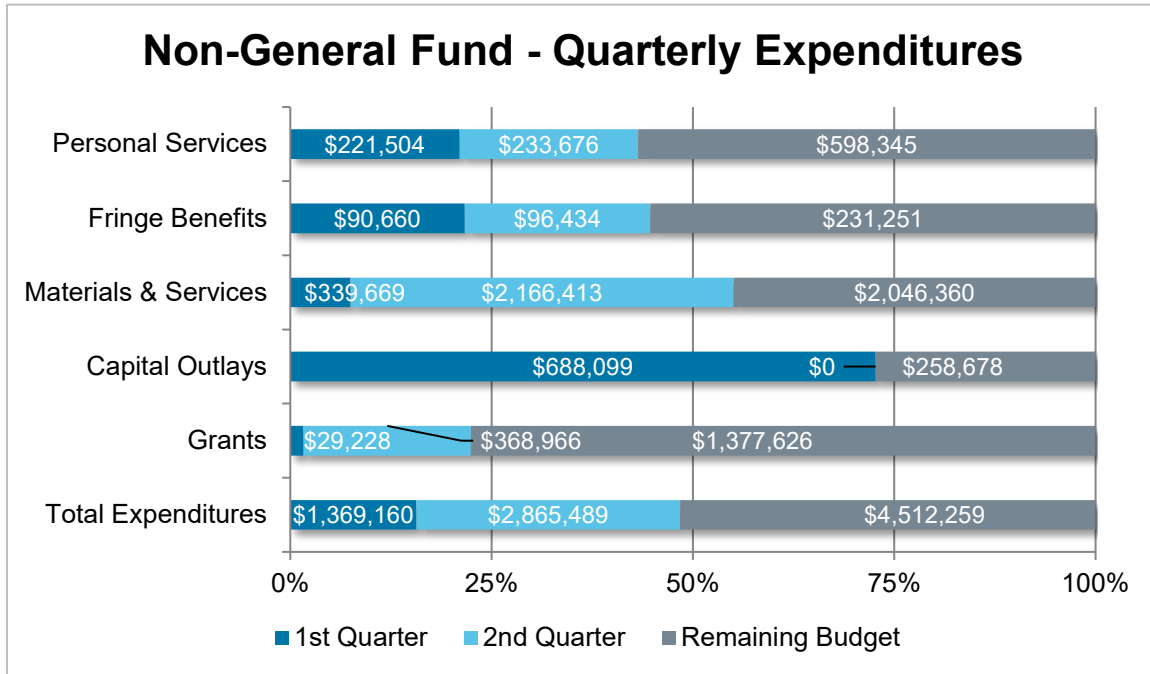
- Service Fees & Charges revenue include the proportionate shares of participating entities which are typically billed late in the 1<sup>st</sup> quarter and received in the 2<sup>nd</sup> quarter. The proportionate shares of participating entities for 2021 and 2022 are provided in the table below.

Non-General Fund – Expenditure Analysis



- The non-general fund expenditures for Emergency Management and Homeland Security are estimated to be **\$8,746,908** for 2022.

- Second quarter expenditures of **\$2,865,489** represent **32.8%** of the budgeted amount for the year. YTD expenditures of **\$4,234,649** represent **48.4%** of the budgeted amount for the year.
- Year-to-date Materials & Services expenditures of \$2,506,082 represent 55.0% of the budgeted amount for the year. Expenditures in this category were \$1,504,796 or 150.3% higher than the same period in 2021. The increase in expenditures is driven by the purchase of radios for the County's upgraded radio system.
- Year-to-date Capital Outlays expenditures of \$688,099 represent 72.7% of the budgeted amount for the year and are related to the upgrade of the County's radio system.
- Year-to-date Grants expenditures of \$398,194 represent 22.4% of the budgeted amount for the year. Expenditures within this budget category are expected to occur primarily in the 3<sup>rd</sup> and 4<sup>th</sup> quarters and are expected to align with the budget by the end of the year.

- There were twelve pay periods through the end of the 2<sup>nd</sup> quarter, which would equate to 46.2% of the budgeted amount. The variance in Personal Services expenditures during the first half the year is attributed to the vacancy of one full time and two part-time positions.
