


2023 TOTAL GENERAL FUND REVENUE BY SOURCE \$598 MILLION






2023 GENERAL FUND APPROPRIATIONS BY CATEGORY \$594 MILLION






2023 GENERAL FUND APPROPRIATIONS BY FUNCTION \$594 MILLION



2023 TOTAL ALL FUNDS EXPENDITURES BY FUNCTION \$2.0 BILLION










2023 TOTAL ALL FUND REVENUE BY SOURCE \$1.8 BILLION






POPULATION GROWTH




Franklin County Total Population
