Mission

The mission of the Franklin County Board of Elections is to provide election services, information, and education to the residents of Franklin County so they may exercise their right to vote and have confidence that the elections are fair, impartial, and accurate.

Strategic Focus

Primary Initiative: Election Day - To ensure that all Election Day polling locations are fully staffed with qualified and trained Precinct Election Officials (PEOs) and to ensure that polling locations have sufficient quantities of voting equipment and are accessible to voters.

Primary Issue: Voter Participation - Voter participation in non-federal elections is lower compared to federal presidential elections. Lower voter turnout presents unique challenges for ensuring that Franklin County voters have the necessary election information needed to exercise their right to vote. It also presents more challenges for recruiting and training enough Election Day poll workers. - With ongoing election law changes, the KnowB4Ugo education and outreach program will provide accurate voting information to voters, candidates, and civic organizations, and to train Election Ambassadors to educate voters in their local communities. A voter information guide will be sent to each registered Franklin County household to remind voters of critical election deadlines and voter ID requirements. Board staff will continue to launch new programs to recruit and retain Election Day poll workers.

Program: Precinct Election Official (PEO)

About this measure	Why it is important		
Precinct Election Officials (PEOs) are responsible for signing a polling location digital payroll sheet on the electronic poll book on Election Day. Postelection, PEO Department staff review, verify, and process the digital payroll sheets to create a final report for submission to the Auditor's Office.	The Franklin County Board of Elections must recruit approximately 5,000 bi-partisan PEOs to administer a full countywide election. Every PEO completes a two to three hour in-person training class with hands-on exercises that simulate the Election Day experience. Additional training is provided through online classes, and practice makes perfect review sessions. Electronic poll books play a critical role in processing voters efficiently and accurately to determine the proper voting method (regular or provisional).		
What is being done			


The Franklin County Board of Elections staff continually innovate new methods to recruit and maintain PEOs. Current programs include Youth at the Booth - targeting 17 and 18 year old high school students, Champions of Democracy - partnering with local businesses and agencies to recruit their employees. partnering with local and state governments to give employees the opportunity to serve without using a personal or vacation day, utilizing sponsored ads across multiple social media platforms, utilizing targeted telephone and text messaging campaigns, and assigning staff to recruit voters visiting the Early Vote Center.


The variance from the 2024 Approved Budget to the 2024 Projection is primarily attributed to a state reimbursement for E-Pollbooks.

2025 Recommended Budget Revenues by Category




The variance from the 2024 Approved Budget to the 2024 Projection is primarily attributed to the increased cost for the Presidential Election in the General Fund, and the purchase of additional voting machines and replacement E-Pollbooks in the Non-General Fund.

The variance from the 2024 Approved Budget to the 2025 Recommended Budget is primarily attributed to a decrease in election related expenditures due to no statewide election anticipated in 2025 in the General Fund, which is partially offset by the E-Pollbook SAAS fees in the Non-General Fund.



Vacancy Credit

The vacancy credit process is designed to more accurately reflect the expenditures for Salaries & Wages and Fringe Benefits within the agency budget request. The calculations for the budget process begin with funding all approved positions for the entire year excluding new positions contained in a Request for Results. Vacancy credits take into account that not all approved positions will be filled for the entire year. The methodology historically used to estimate an agency's vacancy credit utilizes a four-year history of unused personnel budgets to determine an appropriate percentage of Salaries & Wages and Fringe Benefits that will likely remain unspent at the end of the year. However, vacancy credits may vary from the four-year average due to staffing trends or the number of positions supported within a fund. Vacancy Credits may also differ between Salaries & Wages and Fringe Benefits due to the timing and fixed amount charged for healthcare.

Administrative Services

Program Purpose

The Administrative Services department serves prospective candidates by providing ballot access information and candidate filing material, including petitions, as well as conducting audits of candidate, officeholder, and political action committee finance reports.

Primary Services

- Provide candidates with information and materials, including petitions and requirements for being a candidate.
- Process and review candidate filings and fees received for each election cycle.
- Prepare and publish election notices to the public.
- Audit and publish campaign finance reports.

- Provide voter outreach and education.

The Precinct Election Official (PEO) program recruits and trains paid volunteers to serve as PEOs at Election Day polling locations.

Primary Services

- Recruit poll workers for each election cycle.
- Schedule poll workers for Election Day.
- Provide in-person and online training to poll workers.
- Conduct in-person and online PEO training.

Voting

Program Purpose

The voting program encompasses Election Day voting, absentee voting, and election operations and logistics support. The voting program allows Franklin County voters the opportunity to cast a ballot at any scheduled election.

Primary Services

- Design, proof, and produce ballots. Maintain and program electronic poll books. Manage ballot tabulation and reconciliation for each election cycle.
- Manage early voting including absentee voting by mail and early in-person voting at the Board of Elections Early Vote Center.
- Produce and pack materials needed at each polling location for each election.
- Secure polling locations and manage the delivery of voting equipment to polling locations for each election.
